This informational sheet has been prepared to aid in executing the application for the position of volunteer firefighter for Natchitoches Parish Fire Protection District # 9. The application must be clear and legible.

Please understand that it may be several weeks before you are contacted and a final decision is made. During this time a background investigation will be preformed.

Please note that willfully withholding information or making false statements on this application will be basis for rejection by, or dismissal from Natchitoches Parish Fire District # 9.

Natchitoches Parish Fire Protection District # 9 operates out of three (3) stations located within our district. They are the Central Station located on Edenborn Street in Campti, the Black Lake Station located on the Campti Bayou road near its intersection with the Hart Road and the Fairview Alpha Station located on US 71 in Fairview Alpha.

You will need to furnish the following documents or copies with you application if applicable.

- Drivers License
- Any Certifications or Specialized Training etc.

All applications will be given careful, fair and equal consideration. You will be notified if and when an interview with the Fire Chief, or the Board of Directors with Natchitoches Parish Fire District # 9.

Rules and Regulations

1. All Volunteers responding to an alarm must obey all traffic laws and signals. Anyone caught driving at an excessive speed or driving reckless will be subject of dismissal.
2. All equipment that is issued will be the responsibility of the volunteer. Any equipment problems, damaged, or lost equipment must be reported to the Chief immediately.
3. All Volunteers are required to attending training when notified.
4. Volunteers must agree to attend 20 percent of ALL fire related calls. If you are canceled in route, you are still classified as being on scene and must notify personnel that were on scene that you were canceled in route so that you can be placed on the report that is electronically submitted.
5. Volunteers caught repeatedly not wearing the radio pager that is issued to you will be terms for dismissal.
6. No emergency lights are to be used in a private vehicle while in route to a scene unless, we have a letter on file from your insurance company saying that they provide coverage for this. Insurance Companies that provide protection for Fire District # 9 will not provide coverage or pay for any losses incurred with emergency lights on or in a private vehicle.
7. Any Volunteer arrested for DWI, any type drug offense or felony will be terminated immediately without discussion.
8. Any Volunteer that has a suspended or expired Drivers License will be terminated immediately without discussion.
9. All Volunteers are on a probationary period for 1 calendar year and must comply with all the above listed items, additionally probationary Firefighters will be evaluated quarterly by the Fire Chief or someone on his behalf.
10. Probationary Firefighters will not be allowed use of the Fire District Fitness Facility until the following:
 - a. The probationary firefighter can operate all equipment in the Fire Station and would be able to respond with equipment while at the Fitness Facility.
 - b. Has successfully maintained the required response to all fires, which exceed 20 percent (1 in 5) fire calls.
 - c. Must abide by any and all future rules and regulations set forth by the Fire Chief and/or Board of Directors.

By signing below, you are agreeing to abide by the rules and regulations set forth above. In addition, you also agree to abide any future rules, regulations, and instructions by the Fire Chief. Failure to comply with these rules may result in dismissal from the Fire District.

NPFD9 also responds to calls for assistance for motor vehicle accidents or any accident that requires rescue with the “Jaws of Live” that is stationed at the Central Fire Station in Campti, La. The Fire District also has started a water response/recovery unit with underwater divers trained in several areas including black water diving.

The Chief and/or the Board of Directors with NPFD9 will make the final decision pertaining to your position with the Fire District.

By submitting and signing this application, I understand that my position with NPFD9 that it will be necessary to respond to calls for assistance (when not on your regular job) when the need arises.
